Applicable Models

This manual is applicable to DS-3E15XXP series Gigabit Web-managed PoE switch.







NOTE

The front panel of DS-3E1526P switch is similar to that of DS-3E1518P, with differences on 24 gigabit PoE ports, 24 LINK/ACT, 24 PoE indicators and fiber optical ports are port 25 & 26.

Gigabit PoE Ports

Used for supplying power to connected powered devices (PDs) via network cables.

Gigabit SFP Ports

Used for connection with other devices via optical fiber cables when plugged into with an optical module.


Device Installation

Prerequisites:

- Ensure that the desktop or rack is stable and firm enough.
- The room must be well-ventilated. Keep at least 10 cm distance around the device for heat dissipation.
- Keep at least 1.5 cm vertical distance between two adjacent devices for rack-mount installation.

DS-3E0505/10P series switches support desktop and wall-mounted installation. See the figure below for wall-mounted installation.





Grounding Terminal

Used for connecting to the grounding cable to protect the switch from lightning.

Power Supply

Used for connecting the switch to the socket. Use the attached power cord for connection.




DS-3E1518/26P

DS-3E1518/26P series switches only support rack installation. Follow the steps below for rack installation.

- Check the grounding and stability of the rack.
- Use the attached screws to fix the two L-shaped brackets to the sides of the switch.



- Place your switch on the rack, fix it to the rack with self-prepared screws to stably install your switch.




Grounding


Purpose:

Grounding is used to quickly release overvoltage and overcurrent induced by lightning for switch, and to protect personal safety. Select the appropriate grounding method according to your needs.


With Grounding Bar:

3. Click **OK**. Go to the login page.




4. Enter the **User Name** and **Password**, and click **Log In**.

Port Connection

PoE Port Connection:

Connect the switch to the PoE ports of a peer device, including network camera, NVR, switch, etc.



Fiber Optical Port Connection:




- Do not bend fiber optic (curvature radius ≥ 10 cm) overly.
- Do not look directly at fiber optic connector for laser is harmful to eyes.

1. Connect the two paired SFP optical modules with an optical fiber.
2. Hold the SFP optical module from one side, and smoothly plug it into the switch along with the SFP port slot until the optical module and the switch are closely attached.
3. After powering on your switch, check the status of Link/Act indicator. If the indicator is lit, the link is connected. If the indicator is unlit, the link is disconnected. Check the line, and make sure peer devices have been started.

Power-On Checking

Before powering your switch, make sure that:

- The operating power supply is compliant with rated input standard.
- Port cables and grounding cables are correctly connected.
- If there is outdoor cabling, connect a lightning rod and lightning arrester to the cable.



Please use the attached power cord in package to power up the switch.

Network Configuration

After the switch is activated, you can change the network configuration to further manage the switch.

1. Go to **System Management** → **Network Configuration**.

2. Change the IP address, mask address, and the gateway address as needed. You can log in to the new IP address to access to the device next time.

See the following table and check whether your devices are correctly connected. After proper connection, you can use your switch without doing any settings.

Indicator	Status	Description
PWR	Steady on	The switch is powered on normally.
	Unlit	No power supply is connected or the power supply is working incorrectly.
Link/Act	Steady on	The port is connected.
	Blinking	The port is transmitting data.
PoE	Unlit	The port is disconnected or connection is abnormal.
	Steady on	The switch is supplying power to the PD properly.
PoE-MAX	Unlit	The switch is disconnected from PD, or provides power supply to PD abnormally.
	Steady on /Blinking	The output power of the switch is about to reach or already reaches the upper limit. The power supply may be abnormal if more devices are connected.
PoE-MAX	Unlit	The switch is supplying power to the PD properly.



The switch supports auto MDI/MDIX of ports, you can use straight-through cable or crossover cable to connect the switch and peer Ethernet devices.


Activation

You can manage the switch on the Web. For the first time usage, you must activate the device and configure the password.

Prerequisites

The computer and the switch are on the same network segment. The default IP of the switch is 192.168.1.64.

1. Enter the default IP 192.168.1.64 in the browser address bar. You are recommended to use the newest version of the following browsers: IE 10+, Edge, and Chrome 31+.
2. Configure the password and confirm it.
